ESPI'S CITY SMART SCHOLARS 5TH THROUGH 8TH GRADE PROGRAM IS DESIGNED FOR STUDENTS FROM FAMILIES WHO CANNOT AFFORD PRIVATE TUTORING AND ARE FROM COMMUNITIES WHICH ARE UNDER-REPRESENTED IN NEW YORK CITY'S SELECTIVE HIGH SCHOOLS. THE INITIAL PROGRAM MEETS IN UPPER MANHATTAN ON SATURDAYS DURING THE SPRING. STUDENTS WORK FOR A FULL DAY, RECEIVING INSTRUCTION IN ENGLISH LANGUAGE ARTS AND MATH AND PREPARATION FOR THE NEW YORK STATE 5TH GRADE TEST, AS WELL AS SEVERAL FIELD TRIPS. STUDENTS WHO COMPLETE THE PROGRAM BECOME ELIGIBLE FOR A FOUR-WEEK SUMMER PROGRAM THAT EMPHASIZES WRITING AND CRITICAL READING SKILLS AND MATH PROBLEM-SOLVING. THOSE WHO RECEIVE HIGH SCORES ON THEIR 5TH GRADE ENGLISH LANGUAGE ARTS AND MATH TESTS WILL ALSO BE ELIGIBLE FOR A 16-WEEK PROGRAM IN THE FALL TO PREPARE THEM FOR THE HUNTER COLLEGE HIGH SCHOOL (HCHS) ADMISSIONS TEST, GIVEN TO 6TH GRADERS IN JANUARY.
